INVITATION TO BID FOR THE

Supply and Delivery of Various Medical Equipment for the Philippine Sports Institute (PSI)

1. The Philippine Sports Commission under the National Sports Development intends to apply the sum of Eighteen Million Five Hundred Twelve Thousand Five Hundred Eighty Pesos (\$\P\$18,512,580.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply and Delivery of Various Medical Equipment for the Philippine Sports Institute (PSI).

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The Philippine Sports Commission now invites bids for Supply and Delivery of Various Medical Equipment for the Philippine Sports Institute (PSI). Delivery of the Goods is required within sixty (60) daysfrom the date of receipt by the winning bidder of the NTP. Bidders should have completed, within 3 years from the date of submission and receipt of bids, a contract similar to the project which is at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
- 4. Bidding is restricted to Filipino Citizens/Sole Proprietorships, Partnerships, or Organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens pursuant to RA 5183 and subject to Commonwealth Act 138.

- 7. The Philippine Sports Commissionwill hold a Pre-Bid Conference on 01 December 2017, 10:00AM at BAC Bidding Room Ground Floor Administrative Building, Rizal Memorial Sports Complex P. Ocampo Sr. St., Malate Manila, which shall beopen to prospective bidders.
- 8. Submission of bids shall be on 14 December 2017 from 8:00 AM to 9:30 AM at the BAC Bidding Room Ground Floor Administrative Building, Rizal Memorial Sports Complex P. Ocampo Sr. St., Malate Manila. Opening of bids shall be on the same day, 14 December 2017 at 10:00 AM at the BAC Bidding Room Ground Floor Administrative Building, Rizal Memorial Sports Complex P. Ocampo Sr. St., Malate Manila. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids shall not be accepted.
- 9. The Philippine Sports Commissionreserves the right to reject any and all bids, declare a failure of bidding at any time prior to contract award, without thereby incurring any criminal, civil, or administrative liability, regardless of the outcome of the bidding processor not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
