INVITATION TO BID FOR THE

**IMPROVEMENT OF NORTH AND SOUTH DORMITORIES LOCATED AT
RIZAL MEMORIAL SPORTS COMPLEX, P. OCAMPO SR. ST, MALATE,
MANILA**

1. The Philippine Sports Commission (PSC), through the General Appropriations Fund intends to apply the sum of *Eleven Million Five Hundred Fifty Thousand Eight Hundred Thirty Three Pesos and Seventy Centavos (P11,550,833.70)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *Improvement of North and South Dormitories located at Rizal Memorial Sports Complex, P. Ocampo Sr. St, Malate, Manila.*

Bids received in excess of the ABC shall be automatically rejected during the Opening of Bids

2. The PHILIPPINE SPORTS COMMISSION now invites contractors with PCAB License and Registration appropriate to the project cost to bid for *Improvement of North and South Dormitories located at Rizal Memorial Sports Complex, P. Ocampo Sr. St, Malate, Manila.* Completion of Works is required *within Ninety (90) calendar days from the date of receipt of the Notice to Proceed.* Bidders should have completed a contract similar to the project which is at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.



5. A complete set of Bidding Documents may be purchased by interested Bidders starting 23 November 2017 from the address above and upon payment of fee for the Bidding Documents in the amount of *Twenty Five Thousand Pesos (P25,000.00)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

6. The PHILIPPINE SPORTS COMMISSION will hold a Pre-Bid Conference on 01 December 2017 at 10:00 AM at the BAC Bidding Room Ground Floor Administrative Building, Rizal Memorial Sports Complex P. Ocampo Sr. St., Malate Manila.
7. Submission of bids shall be on 14 December 2017 from 8:00 AM to 9:30 AM at the Office of the BAC Secretariat, c/o Office of the BAC Chairman, 4/F Administration Building, Rizal Memorial Sports Complex, P. Ocampo Sr. St., Malate, Manila. Opening of bids shall be on the same day, 14 December 2017 at 10:00 AM at the BAC Bidding Room Ground Floor Administrative Building, Rizal Memorial Sports Complex P. Ocampo Sr. St., Malate Manila. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids shall not be accepted.
8. The PHILIPPINE SPORTS COMMISSION reserves the right to reject the bid, not to award the contract or declare a failure of bidding at any time prior to contract award, without thereby incurring any criminal, civil, or administrative liability, regardless of the outcome of the bidding process.
