Ocampo Sr. St., Malate, Manila. Bids must be delivered to the address above. All bids must be accompanied by a bid security in any of the acceptable forms in the amount stated in the ITB Clause.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address above. Late bids shall not be accepted.

The Commission reserves the right to reject any and all bids, declare a failure of bidding or not to award the contract on the following ground:

- There is prima facie evidence of collusion:

- There is/are justifiable ground/s where the contract will not redound to the benefit of the government without incurring any liability to the affected bidder/s.
