Ocampo Sr., St., Malate, Manila from Mondays to Fridays, 8:00 am to 5:00 pm.

The Philippine Sports Commission will hold a Pre-Bid Conference at the BAC Bidding Room located at the Ground Floor, Administrative Building, Rizal Memorial Sports Complex, P. Ocampo Sr. St., Malate, Manila. Eligibility, technical and financial documents must be delivered to the address above. All submissions must be accompanied by a bid security in any of the acceptable forms in the amount stated in the ITB Clause.

Eligibility, technical and financial documents will be opened in the presence of the bidders' representatives who choose to attend at the address above. Late submissions shall not be accepted.

The Commission reserves the right to reject any and all bids, declare a failure of bidding or not to award the contract on the following grounds:

- There is a prima facie evidence of collusion;
- The BAC failed to follow the prescribed bidding procedures;
- There is/are justifiable ground/s where the contract will not redound to the benefit of the government without incurring any liability to the affected bidder/s.
