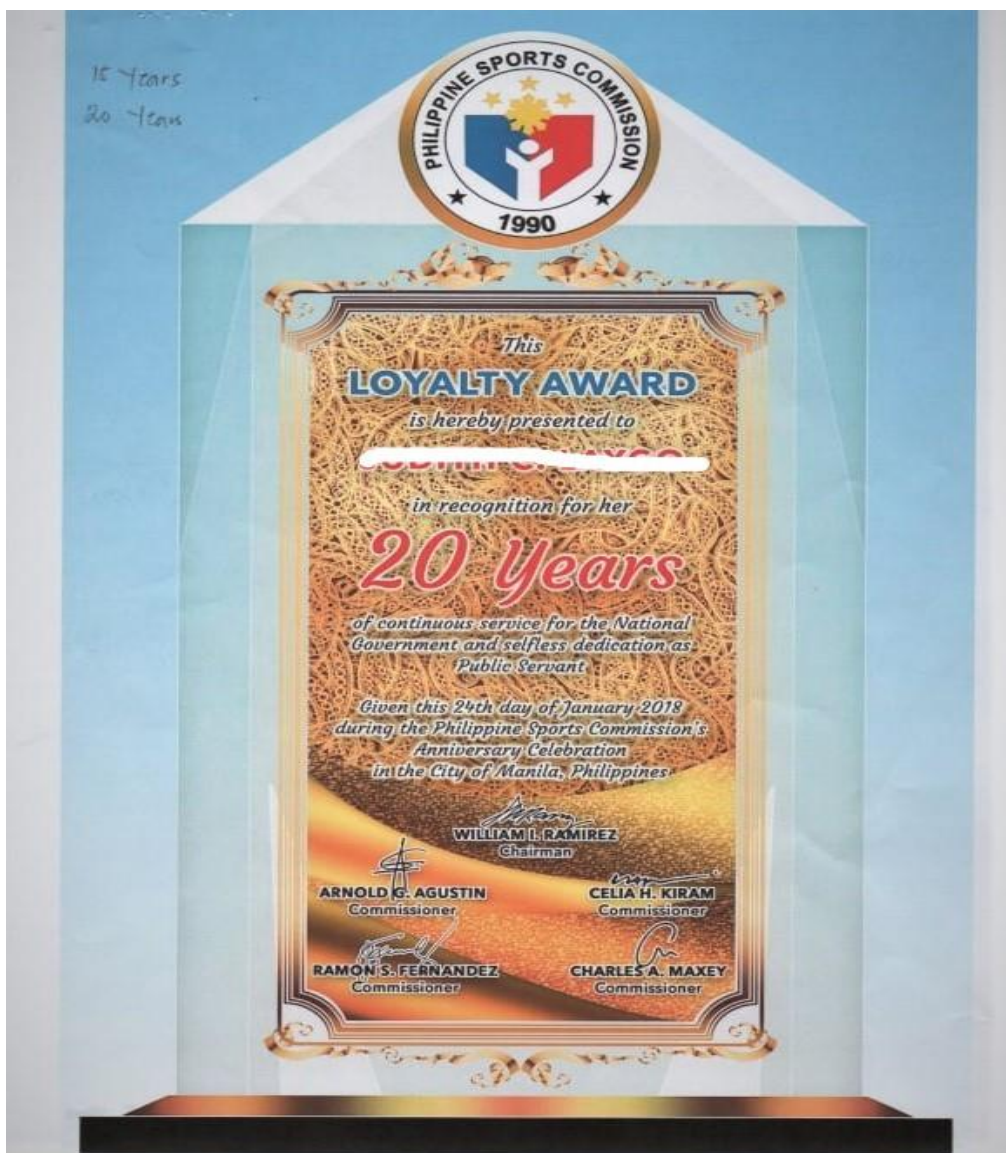
- There is prima facie evidence of collusion;
