

Contract Agreement for Van Rental for Doping Control Officers' Re- accreditation Training Course

CONTRACT AGREEMENT

This Agreement is made and executed in the City of Manila, Philippines, this _____ day of October 2024 by and between:

PHILIPPINE SPORTS COMMISSION, a national government agency exercising corporate powers, created and existing under Republic Act No. 6847 with principal office address at Administration Building, Rizal Memorial Sports Complex, Pablo Ocampo Sr., St., Malate, Manila, represented herein by its Chairman, **RICHARD E. BACHMANN**, hereinafter referred to as the **PSC**;

- and -

MNM SHUTTLE DISPATCHING SERVICES, duly organized and existing under the laws of the Republic of the Philippines, with principal address at 116 Narra St., Marikina Heights, Marikina City, represented herein by its Operations Manager, **BERNARDO R. BALANGUE**, hereinafter referred to as the **MNM**.

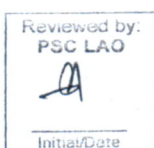
WHEREAS, the Entity, thru its Bids and Awards Committee (BAC), invited prospective suppliers to apply for eligibility and to submit proposals/quotations for the **Van Rental for Doping Control Officers' Re-accreditation Training Course**;

WHEREAS, in response to said invitation, **MNM** signified its intention by submitting its eligibility requirements and quotation;

WHEREAS, the Entity, pursuant to Bids and Awards Committee (BAC) Resolution No. GS 150-2024 dated 9 October 2024 declared **MNM** as the supplier with the Lowest Calculated and Responsive Quotation, legally, technically and financially capable supplier to perform the subject project in accordance with the provisions of R.A. 9184, *Copy of the said BAC Resolution is hereto attached as Annex "A,"*

NOW, THEREFORE, for and in consideration of the foregoing premises and of the terms and conditions herein set forth, the parties by these presents agreed as follows:

- MNM** shall provide transport services for Doping Control Officers' Re-accreditation Training Course in conformity with the following technical specifications:
 - 1 unit Van in which can accommodate 12 persons with luggage and cargoes;
 - Inclusive of fuel, driver's fee, toll fees, parking fees, driver's meals and accommodation;
 - Fully air-conditioned;
 - 10 hours per day;
 - Route:
NAIA Airport - HOTEL
HOTEL – VENUE (Within cities of Metro Manila)
HOTEL – NAIA Airport
 - Inclusive dates: October 17-19, 2024.
- In consideration of the services to be rendered, the **PSC** shall pay **MNM** the total amount of **NINETEEN THOUSAND AND EIGHT HUNDRED PESOS (Php 19,800.00)** subject to the submission of Letter of Request for Payment per COA Circular No. 2023-004, Trip tickets and Billing Statement/invoice.
- The following documents as required by the 2016 Revised Implementing Rules and Regulations of R.A. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz:



- a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract;
 - iv. Supplemental or Bid Bulletins, if any.
- b. Winning supplier's proposal, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
- c. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- d. Performance Security, if any;
- e. Notice of Award of Contract; and the Bidder's conforme thereto; and
- f. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. This Contract Agreement is subject to the usual government accounting and auditing rules and regulations.


