RESOLUTION NO. GS 204-2024

WHEREAS, on 09 October 2024, the Batang Pinoy 2024 Committee has requested the provision for rental of timing and result services intended for the conduct of Batang Pinoy National Championships 2024 in Puerto Princesa, Palawan specifically for Cycling Events. The project was adopted through the issuance of Board Resolution No. 927-2024, approving the appropriation for the purchase of aforementioned project:

WHEREAS, the Purchase Request was approved on 11 November 2024 with an ABC amounting to Six Hundred Twenty Eight Thousand Five Hundred Pesos (PhP628,500.00), and the subsequent declaration of the Head of Procuring Entity (HoPE) of the mode of procurement under Section 50 Direct Contracting of R.A No. 9184;

WHEREAS, pursuant to Section 50 and Annex "H" of R.A No. 9184 and its Implementing Rules and Regulations (IRR), to wit:

Direct Contracting or single source procurement is a method of procurement of Goods that does not require elaborate Bidding Documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with the conditions of sale. The offer may be accepted immediately or after some negotiations. Direct contracting may be resorted to by concerned Procuring Entities under any of the following conditions:

- a) **Procurement of Goods of proprietary nature which can be obtained only from the proprietary source, i.e. when patents, trade secrets, and copyrights prohibit others from manufacturing the same item;**
- b) *When the procurement of critical components from a specific supplier is a condition precedent to hold a contractor to guarantee its project performance, in accordance with the provisions of its contract; or*
- c) *Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GoP.*

WHEREAS, in line with the principle of transparency and competitiveness, the Request for Quotation (RFQ) was posted on 13 November 2024 in the PhilGEPS, PSC Website, PSC

Social Media Platforms, Procurement Bulletin Board, and various conspicuous place reserved for this purpose in the premises of the Philippine Sports Commission;

WHEREAS, WJC Enterprises, the sole and authorized distributor of electronic timing system in the Philippines, has submitted its accomplished RFQ to the BAC on the deadline set forth, and the quotation was opened and evaluated on 18 November 2024 with the following results:


