2024 Cycling Events in Puerto Princesa City, Palawan**

**CONTRACT AGREEMENT**

This Agreement is made and executed in the City of Manila, Philippines, this \_\_\_\_\_  
by and between:

**PHILIPPINE SPORTS COMMISSION**, a national government agency exercising corporate powers, created and existing under Republic Act No. 6847 with principal office address at Administration Building, Rizal Memorial Sports Complex, Pablo Ocampo Sr., St., Malate, Manila. represented herein by its Chairman, **RICHARD E. BACHMANN**, hereinafter referred to as the **PSC**;

- and -

**WJC ENTERPRISE**, an entity duly existing and organized under the law of the Republic of the Philippines with principal office address at Malacampa, Camiling, Tarlac, represented herein by its Proprietor, **WILSON A. CHENG**, hereinafter referred to as the **WJC ENTERPRISE**;

**WHEREAS**, the PSC, thru its Bids and Awards Committee (BAC), invited prospective suppliers to apply for eligibility and to submit quotations for the **Rental of Timing and Results Services for Batang Pinoy 2024 Cycling Events in Puerto Princesa City, Palawan**;

**WHEREAS**, in response to said invitation, **WJC** signified its intention by submitting its eligibility requirements and quotation;

**WHEREAS**, the PSC, pursuant to Bids and Awards Committee (BAC) Resolution No. GS 204-2024 dated 19 November 2024 declared **WJC** as the supplier with the Single Calculated and Responsive Quotation, legally, technically and financially capable supplier to perform the subject project in accordance with Section 50 and Annex "H" or through the mode of Direct Contracting under R.A. 9184, *Copy of the said BAC Resolution is hereto attached as Annex "A;"*

**NOW, THEREFORE**, for and in consideration of the foregoing premises and of the terms and conditions herein set forth, the parties by these presents agreed as follows:

- WJC** shall provide Rental of Timing and Results Services to be used for the conduct of Cycling Events at Batang Pinoy 2024 in conformity with the following technical specifications:

- In consideration thereof, the **PSC** shall pay **WJC** the total amount of **SIX HUNDRED TWENTY-EIGHT THOUSAND AND FIVE HUNDRED PESOS (Php 628,500.00)** subject to the submission of letter of request for payment per COA Circular 2023-004, Certificate of Service Rendered and Billing Statement.

3. The following documents as required by the 2016 Revised Implementing Rules and Regulations of R.A. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz:

- i. Schedule of Requirements;
  - ii. Technical Specifications;
  - iii. General and Special Conditions of Contract;
  - iv. Supplemental or Bid Bulletins, if any.
- b. Winning supplier's proposal, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - c. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - d. Performance Security, if any;
  - e. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - f. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. This Contract Agreement is subject to the usual government accounting and auditing rules and regulations.






