

Contract Agreement for Supply and Delivery of Packed Meals for the Conduct of Sports Nutrition Day

CONTRACT AGREEMENT

This Agreement is made and executed in the City of Manila, Philippines, this \_\_\_\_\_ by and between:

**PHILIPPINE SPORTS COMMISSION**, a national government agency exercising corporate powers, created and existing under Republic Act No. 6847 with principal office address at Administration Building, Rizal Memorial Sports Complex, Pablo Ocampo Sr., St., Malate, Manila, represented herein by its Chairman, **RICHARD E. BACHMANN**, hereinafter referred to as the **PSC**;

- and -

**BULBRITE SUNLITE BISTRO INC.**, duly organized and existing under the laws of the Republic of the Philippines, with principal address at EMX 121-122 SM Mall of Asia, JW Diokno Blvd. Brgy. 76, Pasay City, represented herein by its Operations Director, **CHRISTIAN KEVIN P. FRANCISCO**.

**WHEREAS**, the **PSC**, thru its Bids and Awards Committee (BAC), invited prospective suppliers to apply for eligibility and to submit proposals/quotations for the *Supply and Delivery of Packed Meals for the Conduct of Sports Nutrition Day*;

**WHEREAS**, in response to said invitation, **BULBRITE SUNLITE BISTRO INC.** signified its intention by submitting its eligibility requirements and quotation for the aforementioned project;

**WHEREAS**, the **PSC**, pursuant to Bids and Awards Committee (BAC) Resolution No. GS 061-2025 dated 22 April 2025 declared **BULBRITE SUNLITE BISTRO INC.** as the supplier with the Single Calculated and Responsive Quotation, legally, technically and financially capable supplier to perform the subject project in accordance with the provisions of R.A. 9184, Copy of the said BAC Resolution is hereto attached as Annex "A";

**NOW, THEREFORE**, for and in consideration of the foregoing premises and of the terms and conditions herein set forth, the parties by these presents agreed as follows:

1. **BULBRITE SUNLITE BISTRO INC.** shall provide, supply and deliver of Packed Meals for the Conduct of Sports Nutrition Day in conformity with the following technical specifications:

2. In consideration of the services to be rendered, the **PSC** shall pay **BULBRITE SUNLITE BISTRO INC.**, the total amount of **ONE HUNDRED THIRTY-FIVE THOUSAND PESOS (Php 135,000.00)** subject to the submission of Letter of Request for Payment per COA Circular No. 2023-004 and Billing Statement/invoice.
3. The following documents as required by the 2016 Revised Implementing Rules and Regulations of R.A. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz:
  - i. Small Value Procurement Documents;
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract;
    - iv. Supplemental or Bid Bulletins, if any.
  - ii. Winning supplier's proposal, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - iii. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iv. Performance Security, if any;
  - v. Notice of Award of Contract, Notice to Proceed; and the Bidder's conforme thereto; and
  - vi. Winning supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. This Contract Agreement is subject to the usual government accounting and auditing rules and regulations.
